**Business and Company Resource Center** - Company profiles include (where available) company histories, chronologies, rankings, financials, investment reports, products and brands, suits and claims, industry overviews, plus links to business news articles. Search for detailed company and industry news and information.

**Business Source Premier**- Selective full-text articles for 2,800 international and scholarly business journals covering such fields as management, economics, finance, and accounting. This database also includes **Datamonitor's** 10,000 company profiles in PDF report format.

**Emerald** - Primarily the full text of management-related articles in various fields.

**General Business File** - Analyses of company performance, industry events, and the latest trends in management, economics, and politics. Access trade publications, newspapers, and journal articles.

**Hoovers** - Includes company profiles, corporate histories, executives, financials and news for 16 million U.S. and international companies. Also includes information about competitive landscape and industry benchmarks.

**Hospitality & Tourism Index**- International coverage dating back to the 1960's relating to all areas of hospitality, travel, and tourism. Includes demographics and statistics, development and investment, food and beverage management, hospitality law, hotel management and administrative practices, leisure and business travel, market trends, technology, and related subject areas such as consumer psychology, marketing, and real estate.

**Lexis Nexis Academic** - A news, law, and business information service with full-text access to nearly 6,000 newspapers, periodicals, and reference sources. This database includes access to law reviews, court opinions, and federal and state statutes.
